



WEDDING CONTRACT & BOOKING FORM

This agreement is between Fusion Photography, hereinafter called the "Studio," and the undersigned, hereinafter called the "Client", relating to the wedding that will take place at:

have read & understood this contract & we agree to be bound by the following terms & conditions:

Service & Coverage

The parties agree that Fusion Photography will exclusively reserve the above date & provide the services of professional photography. Coverage & inclusions will be as per attached order form.

Payment Policy & Expenses

A retainer of \$1000 is paid to exclusively reserve the above date for the client's wedding. The Client will pay the remaining balance of package ordered at least four (4) weeks prior to the event, plus reimbursement (if applicable) of any travel expenses incurred that the client has agreed to cover. Non-payment of any fees releases the Studio from any and all obligations defined in this agreement. If the Client cancels the wedding or this contract a refund of the retainer (less a \$250 administration fee) will only be given if & when the Studio books a replacement wedding, and only after the replacement client has paid in full. If another booking is not found the retainer will be forfeited. In the case of postponement, the retainer may be applied to the new date, subject to Studio availability. The retainer is not transferrable to any other parties. The Client is responsible for booking venues and for any shooting fees applicable for their use.

Copyright Agreement & Model Release

*In accordance with Australian Copyright Law, we understand that **Fusion Photography will retain ownership of copyright on all photos & negatives.** The negatives will be made available for purchase from the time that post-production on the images has been completed (allow 6-8 weeks), however if not purchased it is illegal for anyone other than Fusion Photography to produce copies or duplicates without the express permission of the Studio. **We hereby grant the Studio unrestricted rights to use, display & publish any image(s) taken at our wedding in promotional advertising for the Studio or in industry competitions, as well as any reproductions or adaptation thereof for advertising, art, exhibition or editorial.** The usage for any other purpose must be negotiated between both parties.*

Products & Pricing

We have received & understand the Studio's price list, which has been confirmed for our wedding. The supplied prices will be locked in & applicable for up to 3 months after the wedding date. Any additional items ordered after that time will be charged at prevailing prices, and must be paid for at the time of ordering. We also understand that as weddings are booked so far in advance the Studio cannot guarantee that all third-party products sighted at the time of booking will be available and a similar product may have to be substituted. Albums included in a package that are not approved within 6 months may incur a surcharge if prices have risen.
